

Student Dress Code for Year 0 – 6

Students are provided freedom to present themselves at school as they choose, within the following guidelines:

Clothing should be clean and within accepted standards of appropriateness for school and educational activities.

Logos, emblems and graphics must be appropriate and free from gang affiliations, sexual connotations, offensive language, offensive graphics or promoting alcohol or illegal substances.

UNIFORM T-SHIRT

Families will be required to purchase the school uniform T-Shirt allocated to Junior 0-6 syndicate. Students will be required to wear the T-Shirt when representing school at designated events (both sporting and/or educational). Families will be advised at the earliest opportunity when this is necessary.

Teachers/School Management may require students to wear the school T-Shirt for specific activities such as gymnastics, dancing, climbing, running etc, particularly if wearing inappropriate clothing poses a health & safety risk for students, and those around them during that activity.

All Students must wear shorts or calottes, with the option of tracksuit pants (in conjunction with the uniform T-Shirt). Students can supply their own. These must be designed for the purpose and intention of sport or physical activity. For example: jean shorts, fashion shorts, jeans, corduroy pants are not suitable PE attire.

Students with inappropriate clothing or incorrect uniform maybe asked to change and can be excluded from participation.

Options for general footwear are flexible, however these should be appropriate for expected activities during the school day.

Excessively 'short' shorts or skirts (even if they have tights underneath) will not be acceptable. Skirts/shorts should be of a respectable length. Students may be asked to change if not compliant.

There may be specific activities where students will need to have long hair tied up or tied back.

All students must wear appropriate sun hats during Term 1 and Term 4 of each year in accordance with our sun smart policy. Students can provide their own hats which should provide protection for the face, and cover the neck and ears. Sunhats can be ordered from the school office, enquire about pricing. Students without hats will limited or restricted to shaded areas only.

Where these definitions leave a "grey" area, it is at the Principal/Senior Management Team's discretion to make the final decision as to suitability of dress.



Student Dress Code for Year 7 – 13

Students are provided freedom to present themselves at school as they choose, within the following guidelines:

GUIDELINES FOR ALL STUDENTS

Clothing should be clean and within accepted standards of appropriateness for school and educational activities.

Logos, emblems and graphics must be appropriate and free from gang affiliations, sexual connotations, offensive language, offensive graphics or promoting alcohol or illegal substances.

PE UNIFORM & SPORTS HOODIE

Students will be required to wear the school PE uniform for all PE classes and when representing school at designated events (unless a specific team sportswear kit exists) Depending on the activity, appropriate footwear must be worn. Students without correct uniform maybe excluded from participation.

Sports Hoodie is available to all Year 8-13 students that represent the school in sporting activities. Team/School Management may require students to wear the hoodie when travelling to events, or school events. There is an option to have students' names printed. This should be first name or initial (not nicknames)

The concept of the sports hoodie is to encourage students to participate in sport, to create a sense of school pride, belonging, connectedness and unity. Senior students should be mindful of situations when they might choose to wear the hood up, as it can be unintentionally viewed intimidating to other members of the community, and as with hats, should not be over the head in class.

FOOTWEAR

Options for general footwear are flexible, however should be appropriate for expected activities during the school day.

For safety reasons, some departments (food technology and hard materials workshop, PE, optional classes etc) may have specific footwear requirements. Notification will be provided to families at the earliest opportunity. Students without appropriate footwear maybe excluded from participation.



SPECIFIC DRESS CODE GUIDELINES FOR GIRLS

Clothing must not be ripped, see through, showing midriff or belly button, or any inappropriate display of "bare skin" nor excessively short or inappropriately tight fitting.

Tops must fully cover under-garments (students must not have bra, bra tops, camisole or singlet easily visible underneath the top)

Tops must not be strapless, low cut or have spaghetti (or thin straps). Cleavage must not be visible.

Excessively "short" shorts or skirts (even if they have tights underneath) will not be acceptable. Underwear cannot be visible. Skirts/shorts should be of a respectable length. Non-compliant students will be required to change.

Minimum and basic jewelry is acceptable and should be limited to a watch, basic flat ring with no raised or sharp edges, basic stud earrings only (no dangling earrings). Necklaces, if worn, should be reasonably short in length (not chokers) to try and minimize the choking or strangling risk for students.

Body piercings are discouraged as they become a health and safety hazard during certain activities. Students will be required to remove jewelry if deemed too excessive or where it poses a health and safety risk to the student or those around them.

Make-up should be basic and tasteful. Students may be asked to remove excessive make-up.

An appropriate standard of personal hygiene is expected. Hair should be clean and tidy. There may be specific activities where students will need to have long hair tied up or tied back. Hats are not to be worn in the classroom and are restricted to outside use only.

Students will need formal dress attire when attending important school events such as prize giving and award ceremonies. Common sense and appropriateness would prevail.

A dark-coloured knee or full length skirt/dress, blouse/tidy dress top/tidy dress jacket and appropriate footwear would be suitable when representing the school at public or community events.

Where these definitions leave a "grey" area, it is at the Principal/Senior Management Team's discretion to make the final decision as to suitability of dress.



SPECIFIC DRESS CODE GUIDELINES FOR BOYS

Clothing must not be ripped, be clean and in acceptable condition.

Pants must not be low-slung or hang down over torso and must not expose boxers or underwear.

Singlets worn on their own are not appropriate to wear in the classroom environment, particularly where the underarms hang quite low and can expose the chest/nipple/stomach area of the student. Students are required to wear a sleeved shirt.

Bandanas, balaclavas or any other face covering will not be acceptable at any time unless there are special cultural or medical considerations that may be applied at the discretion of the Principal.

Minimum and basic jewelry is acceptable and should be limited to a watch, basic flat ring with no raised or sharp edges. Body piercings are discouraged as they become a health and safety hazard during certain activities.

Necklaces, if worn should be reasonably short in length (not chokers) to try and minimize the choking or strangling risk for students. Students will be required to remove jewelry if deemed too excessive or poses a health and safety risk to the student or those around them.

An appropriate standard of personal hygiene is expected. Hair should be clean and tidy (including facial hair). There may be specific activities where students will need to have long hair tied up or tied back. Hats are not to be worn in the classroom and restricted to outside use only.

Students will need formal dress attire when attending important school events such as prize giving and award ceremonies. Common sense and appropriateness would prevail.

Dark well-fitting pants, dress shirt, tie, dress jacket and appropriate footwear would be suitable when representing the school at public or community events.
