The programme provides training, mentors, facilitators to help our young people have an immersive experience to help them move into adulthood and to engage with and be part of the community.

12 mentors Adult men with 12 students - young men. 13-14 yr olds12 mentors Adult women with 12 students - young women. 12-14 yr olds

Louisa spoke of how the school would like to further support this kaupapa and noted that despite backgrounds - our teenagers struggle with strategies to cope - emotionally/physically/socially.

Fundamentals of Rites of Passage - Separation (tapu), Disconnection, Re-integration.

The followup programme is to reconnect with the same group of young mentama tane and feed back. Create healthy community rites of passage led by mentors.

Gabrielle Parsons spoke positively of growing this kaupapa for young men and women of our community.
